4.1.Methodological overview

The methodology followed in this course is oriented towards the achievement of the learning objectives. It is based on active participation, case studies, teamwork etc. that favor the development of communicative skills and critical thinking. A wide range of teaching and learning tasks are implemented, such as lectures, practice sessions, autonomous work, tutorials, and assessment tasks.

Students are expected to participate actively in the class throughout the semester.

Classroom materials will be available via Moodle. These include a repository of the lecture notes used in class, the course syllabus, as well as other course-specific learning materials, including a discussion forum. Further information regarding the course will be provided on the first day of class

4.2.Learning tasks

The course includes the following learning tasks:

- **Lectures** (1.8 ECTS: 45hours). The teacher presents theoretical contents illustrated with relevant examples
- **Interactive, individual or group activities** (1 ECTS: 25 hours). They can include discussion and presentation of case studies, practical work outside the classroom (field work or visits), and seminars.
- **Autonomous work** (3 ECTS: 75 hours). Students do tasks such as study, readings, preparation of practice sessions and seminars, and summative assignments.
- **Assessment tasks** (0.2 ECTS: 5 hours). A final written examination.
