# 4.Methodology, learning tasks, syllabus and resources

### 4.1.Methodological overview

The methodology followed in this course is oriented towards achievement of the learning objectives. Theoretical contents are combined with the projection of audiovisual materials, reading and interpretation of the main avant-garde manifestos, student participation, discussion and critical reflection. Films and videos will be screened as support materials for teaching.

Student participation in lectures is encouraged through discussion and presentations in class. These presentations should be understood as a personal approach to the aspects discussed in class and should be based on readings or critical analysis of the contents of the course. Other learning tasks may include guided activities, assignments (information search, written reflection, drawn and exposed, discussion and public presentations of works), conferences, visits to buildings and museums and trips.

### 4.2.Learning tasks

The course includes the following learning tasks:

- Lectures. Presentation or explanation by the teacher (and as far as possible from external collaborators when appropriate for a specific topic) accompanied by images and texts that correspond to what has been discussed in class or any other material of interest to the student, such as videos or documentaries.
- Student presentations.
- Individual assignment/project. Choose from the following types:

1) A bibliographic synthesis or writing of general visions on a subject from a bibliography. It provides the student with the

tasks of searching, reading and analyzing a specialized bibliography, selecting and synthesizing the most essential points of a topic, making a coherent writing and preparing a correct presentation with a critical sense , appendices and a correctly prepared bibliography. They must consist of the following parts:

- 1. Presentation of the work (rationale and delimitation of the theme of the work)
- 2. Introduction to the topic (explanation of the geographical, historical context, etc ... in which the phenomenon arises)
- 3. Development of the theme (divided into chapters dealing with different aspects of the artistic phenomenon to be studied)
- 4. Conclusions (where the most significant aspects are briefly explained, the personal contributions that have been made, the points that have not been discussed and why, and the usefulness that this work has had in the student's training).
- 5. List of the consulted bibliography, classified in general and specific and in alphabetical order of the surnames of the authors, and well cited. Example:
  - 1. GUTIERREZ, Ramón y ESTERAS, Cristina, Arquitectura y fortificación de la Ilustración a la Independencia Americana, Madrid, Ediciones Tuero, 1993.
  - 2. LAMPEREZ Y ROMEA, Vicente, Historia de la arquitectura cristiana española en la Edad Media, Madrid, Espasa-Calpe, 1930.
- 6. Documentary appendix, if applicable. Transcription of some text of interest for the understanding of work.
- 7. Graphic appendix, if applicable. Photographs (or photocopies of illustrations), plans or graphics of interest for the understanding of the work.

2) Translation of a book chapter or article of interest about Art. The publication to be translated will be indicated by the course teachers, taking into account the preferences of the students.

- 3) Works of a manual or practical nature.
- 4) Volunteer exhibitions.

5) Research initiation projects.

Topic 3. Second avant-garde of the 20th century.

- Informalism
- German neo-expressionism, American abstract expressionism.
- Pop Art.
- Kinetic art.
