4.1.Methodological overview

The methodology followed in this course is oriented towards the achievement of the learning objectives. It is intended that students learn by doing, which requires direction and supervision of their work, but also autonomous study and critical analysis. Knowledge of the various social programs and benefits and design, execution or evaluation of social projects is essential in the professional performance of the social worker. They are also activities that require a high level of practical training, theoretical integration and reflexivity for their correct execution. The methodological strategy of this subject must necessarily adapt to this approach as a way of achieving the proposed learning results. First of all, the subject will have a decided practical orientation for which active methodologies will be applied. Secondly, a close relationship and adequate coordination will be established between the expository part and the practical part. The student's practical work must be placed within the training sequence and must be consistent both with the objectives of the subject and with the set of activities proposed.

In the activities programmed in the subject, the following three teaching methods will be combined: the participatory lecturer, cooperative work, and autonomous work. Finally, the subject will be registered in the ADD (Moodle) incorporating some of the tools that this platform provides to the development of the subject.
