4.1. Methodological overview

The methodology further in this course is oriented towards the achievement of the learning objectives. It is based on active participation and case studies that favor the development of communicative skills and critical thinking. A wide range of teaching and learning tasks are implemented, such as lectures, practice sessions, autonomous work, tutorials and assessment tasks.

4.2. Learning tasks

1. Lectures. The teacher presents theoretical contents illustrated with relevant examples.
2. Practice sessions. Resolution of questionnaires and case studies. They can include discussion and presentation of case studies and seminars.
3. Presentation of a paper review and completion of an activity related to the topic of the review and aligned with the SDGs. Individual and work and oral presentation.
4. Autonomous work. Students do tasks as study, readings, preparation of practice sessions and seminars.
5. Tutorials. Office hours can be used to solve doubts and for follow-up of students' learning progress.
6. Assessment tasks: A final written examination theoretical-practical.
