4.1. Methodological overview

The learning process designed for this topic is based on the following:

With regard to the 40% face-to-face teaching, 60% will be dedicated to the methodology of the theoretical class, and 40% to the methodology of solving practical cases, practices in the classroom or outside the classroom and seminars.

This is justified by the special characteristics of the subject of Theory of Law as reflected in the skills acquired by students, which require the preparation of seminars and the organisation of debates among students to improve their expository and argumentative skills.

4.2. Learning tasks

The programme offered to the student to help him/her achieve the expected results comprises the following activities...

Theoretical classes: expository activities and systematisation of knowledge by the teacher.

- Methodology: theoretical class.
- Relation with the competences to be acquired and learning outcomes: C2, C3.
- Credits: 1.5 ECTS

Practical classes: dynamic teacher-student activities (resolution of practical cases, practical work in the classroom or outside the classroom and seminars).

- Methodology: practical teaching based on text analysis, case studies, presentations and debate.
- Relationship with the competences to be acquired and learning outcomes: C1, C4, C5, C6.
- Credits: 1.0 ECTS

Other training activities: personal study, tutorials, assignments and assessment activities.

- Methodology: adapted to the type of activity (individual or group tutorials, continuous assessment and theoretical-practical written tests, individualised supervision of assignments).

- Relationship with the competences to be acquired and learning outcomes: C1, C4, C5, C6.
- Credits: 3.5 ECTS
