## 4. Methodology, learning tasks, syllabus and resources

### 4.1. Methodological overview

The methodology followed in this course is oriented towards the achievement of the learning objectives. A wide range of teaching and learning tasks are implemented, such as theory sessions, practice sessions and tutorials.

### 4.2. Learning tasks

The teaching-learning process designed for the Management Control subject (6 ECTS) is based on the distribution of the 150 hours between classroom teaching (60 hours) and autonomous work (90 hours). The 60 hours related with lectures are distributed in 30 sessions through the entire semester:

- **Lectures:** 15 hours (sessions of 2 hours).
- **Practice sessions:** 45 hours (tutored practical assignment sessions with the aim of solving practice cases and group work presentations).

Initially, the teaching delivery methodology is planned to pivot around face-to-face classes. However, if necessary for health reasons, face-to-face classes may be taught semi-face-to-face or online.
