#### 1. General information

#### 1.1. Aims of the course

The general objective of this course is for students to become familiar with the different approaches to the study of psychopathology in adulthood, encouraging reading and critical discussion in order to facilitate the justification for the adoption of a particular model during the future development of their professional activity.

Some of the specific objectives are:

- Learn to use the main diagnostic manuals.
- Learn to make a diagnosis, using the main diagnostic manuals, and specifically the DSM 5.
- Learn to make a clinical psychological report.

These approaches and objectives are aligned with the following Sustainable Development Goals (SDGs) of the United Nations 2030 Agenda (https://www.un.org/sustainabledevelopment/es/), in such a way that the acquisition of the learning outcomes of the subject provides training and competence to contribute to some extent to its achievement.

### 1.2. Context and importance of this course in the degree

Clinical Psychopathology is a compulsory subject that belongs to the subject block of the "Personality, Psychological Evaluation and Treatment" knowledge area.

Given the current structure of the degree and the sequence of subjects that make up the clinical psychology itinerary, this subject presents the most relevant aspects that make up psychopathology in adulthood, with the general objective of providing students with the knowledge that allow you to relate this subject to a broader structure of psychological knowledge.

In this subject the most frequent pathologies in the population are studied, except for psychopathologies severe, which will be studied in other subjects.

### 1.3. Recommendations to take this course

It is essential that students have prior knowledge of Psychology and General Psychopathology.

It is recommended that students have knowledge in read English, Internet management, library operation, use of the newspaper library and use of psychological literature databases.

Students who do not have a good level of English are recommended to use the resources available to them (Language Institute or others) to improve a skill that will be necessary in this and other subjects.

# 2. Learning goals

#### 2.1. Competences

**Basic and general**

#### 2.2. Learning goals

The student, to pass this course, must demonstrate the following results...

- Distinguish between the concepts of psychological normality/abnormality.
- Know the main theoretical models of Psychopathology.
- Know the classification systems of the most used mental disorders. Especially the DSM-5.
- Identify the main mental disorders according to clinical characteristics.
- Observe and establish working hypotheses based on the symptoms and signs observed.
- Prepare and defend differential diagnoses in specific cases.

#### 2.3. Importance of learning goals

Psychopathology in adulthood is one of the core subjects in the specialty of Clinical Psychology.

It is important that the future professional of clinical psychology (or the psychologist who is going to dedicate himself to other branches, such as education, social, etc.) knows the diversity of explanatory models of psychopathology, as well as the scientific validity of each one of them, and the use of classification systems, with the aim of knowing how to defend the adoption of one of them for the development of their future professional activity.

Regardless of the future specialization of the psychologist, it is important that he or she knows how to differentiate between symptoms and signs, that he or she is familiar with formulating hypotheses, and that he or she can communicate those results to colleagues or other professionals.

# 3. Assessment (1st and 2nd call)

#### 3.1. Assessment tasks (description of tasks, marking system and assessment criteria)

The student must demonstrate that they have achieved the expected learning outcomes through the following assessment activities.

Written test (grading from 0 to 10) at the end of the semester: 60% of the final grade will be scored. The test may contain true/false, multiple-choice, short-answer, or essay questions.

Continuous evaluation (grading from 0 to 10): 40% of the final grade will be scored. In order for this score to be taken into account in the final grade, students must have participated in at least 80% of the practical classes (otherwise they must take a practical exam at the same time as the theoretical content exam).

All students will have the right to a final exam of the subject.

# 4. Methodology, learning tasks, syllabus and resources

### 4.1. Methodological overview

The learning process that has been designed for this subject is based on the following:

The subject of Clinical Psychopathology will follow an eminently participatory methodology, using the problem-based learning methodology as a reference to stimulate critical thinking, analysis and discussion of the validity of the different theoretical approaches in the student, and ultimately, the development of strategies. necessary to define the model that they will adopt in their professional practice.

Theoretical classes (lectures) will be included, dedicating time to discussion, case analysis classes in pairs, groups and report writing.

In the practices, they will work with cases, diagnosis based on symptoms and signs, familiarization with the bibliographic search, criteria for the selection of articles, as well as their reading, synthesis and discussion.

#### 4.2. Learning tasks

The program offered to students to help them achieve the expected results includes the following activities:

- Master classes, with space for discussion.
- Oral presentations by the students.
- Case analysis.
- Preparation of Clinical Reports.
