4. Academic activities

Expository class. Reading, analysis and commentary of sources. Analysis of texts / news / documents, presentation and critical review of the results obtained. Preparation and conduct of discussions and elaboration of written texts.

This subject has been programmed from a constructivist perspective of learning, according to which the student is the true protagonist of his or her training process. In this sense, the associated Moodle platform is of vital importance.

On theother hand, from this constructivist perspective, Vigotsky's proposal of proximal development is assumed, considering collaborative and cooperative learning as fundamental . That is why works (opinion articles and debates) and daily classroom practices have been encouraged, as far as possible, in which teamwork ,individual responsibility and common results have to be achieved.

5. Assessment system

First Call

Continuous assessment

Practical activities (45% of the final grade), exam (45% of the final grade) and non-compulsory complementary activity (10% of the final grade). The subject is considered passed when the student obtains a minimum score of 50% of the maximum possible grade, taking into account that the practical activities and the exam must be passed separately(passed when a minimum of 50% has been obtained in each of them).

Global assessment

Exam (90% of the final grade), in which a minimum of 50% of the maximum possible score must be obtained, and the non-compulsory complementary activity (10% of the final grade).

Assessment instruments and criteria:

• Practical activities: notebook with classroom practices (5%), an opinion article (20%) and a debate (20%).

Correction rubric.

- Final exam: short answer questions that may be multiple choice, open-ended, essay (short) or a combination of these types. Wrong answers deduct points.
- Complementary non-compulsory activity: reviews of two lectures proposed by the teacher. The score possible in this test will be 0% or 10%. It will only be assessed after passing both the practical activities and the final exam.
