1. General information

Through this subject, the students will be able to acquire experience in the professional world and will provide them with the technical resources and intellectual skills according to their field of intervention so they can apply them in their access to the working world.

2. Learning results

4. Academic activities

The following phases and activities are carried out

Legalization phase of the internship

Student's contact with Universa for the formalization of the practicum

Initial contact of the student with the academic tutor who will sign the documents and agree on how to introduce the student to the entity.

Intermediate phase

Follow-up by the academic tutor in tutorials to ratify the appropriate development of the work in the entity

Completion phase

Contact of academic tutor with entity tutor to gather information on the evaluation of the entity tutor

Delivery of the report to the academic tutor.

5. Assessment system

The final grades for the subject will be obtained by applying the following percentages:

- 40%: Grading of the tutor of the internship entity.
- 40%: Grading of the report by the academic tutor.
- 20%: Grading of tutorials with the academic tutor.

Each and every part must be passed by the student in order to pass the subject.

Tips for writing the final report:

The work must have a coherent structure according to its subject matter, and must have at least the following sections in all cases:

- Cover page: it must include the title of the work, the date of submission, the name of the student, the subject, the name of the tutor at the University and the tutor at the institution.
- Table of contents.
- Introduction: in this brief section, the relevance of the tasks performed, the objectives of the work, the starting
 hypotheses and how the argumentation is articulated throughout the work will be explained.
- · Report Development.
- · Conclusions: the main contributions are presented and reflections on the work carried out are included.
- Bibliography and other materials: the use of extra materials that add information and veracity to the contents provided
 in the Report will be valued. They should not be excessive or exceed the importance of the Report itself. All the
 bibliography and webography will be cited following a standard (according to the field of development of the
 practicum), so that all the references in the report are cited with the same criteria.
- Annexes: All the materials used for the preparation of the work must be included in this section, as well as those
 elements that are considered of great relevance to support the presentation in the report, and that due to their nature
 cannot be included in other sections of the same.

Extension: The length of the report will be, provided that the teacher-tutor of the University does not establish at the beginning of the term other conditions, between 15 and 30 pages with word processor using the font "Times New Roman", size 12, 1.5 spacing, justified text. These conditions may vary; therefore it is necessary to check with the academic tutor

<u>Writing:</u> the work must be properly written. Spelling mistakes, punctuation errors or poor writing may be taken into account negatively when evaluating the work. A technical language is expected, typical of the field of knowledge where the practicum is developed.

<u>Elaboration</u>: the Practicum Report must demonstrate critical thinking based on a personal elaboration of the sources used (use the sources to base arguments).

<u>Previous draft:</u> Before the date of the final delivery of the report, it is advisable to submit to the teacher- tutor an outline explaining how the report will be developed. It would be advisable to have the teacher's approval before the final submission of the report.

REFERENCES FOR QUALIFICATION:

Criteria for evaluation of the entity's tutor

- 1. Technical and learning capacity demonstrated by the student.
- Relational skills and ability to work as part of a team.
- 3. Ability to communicate orally and in writing
- 4. Responsibility, motivation, involvement and initiative at work.

Evaluation criteria of the academic tutor

- 1. Organization of appropriate bibliographic searches through all available means.
- 2. Planning, organization and adequate regulation of autonomous work.
- 3. Original problem solving using their interdisciplinary background.

- 4. Making proposals with ethical criteria, always reasoned and well expressed, that meet the needs and differences in characteristics and gender of the people involved in the practice.
- 5. Approaching relevant initiatives and overcoming difficulties in the implementation of tasks and projects.

Evaluation criteria of the practicum report

- 1. Correctness in academic formal aspects.
- 2. Relevance of the content of the report (Description of the entity and the tasks developed in it, design of an original project appropriate to the scope of the entity, personal intervention proposal, coherence in conclusions and reflections)

The grading will be made by means of the evaluation annexes.

Fraud or total or partial plagiarism in any of the evaluation tests will result in the failure of the subject with the minimum grade, in addition to the disciplinary sanctions that the guarantee committee adopts for these cases.
