- Mastery of the rules and criteria for budget preparation

4. Academic activities

The teaching-learning process that has been designed for the subject "Management Control" of 6 ECTS credits is based on the distribution of the 150 hours of student work into 60 face-to-face hours and 90 non-face-to-face hours. The 60 hours of face-to-

face work are distributed in 30 sessions throughout the semester.

Master classes: 30hours Practical classes: 30hours Personal Study: 90hours Tests Evaluation: 2 hours 6 ECTS150 hours

In principle, the methodology for teaching teaching and its evaluation is planned to revolve around face-to-face classes. However, if circumstances require it, they can be done online.

5. Assessment system

In the first call, students will be able to choose between a continuous evaluation process or a global evaluation, taking into account that the choice of continuous evaluation does not imply the renunciation of a subsequent global evaluation, the grade being the highest of both.

In the second call, students will be evaluated only using the global evaluation system. For continuous evaluation, 3 sections are

proposed (see table below):

1st.- Taking a written test on the theoretical contents of the program throughout the course (approximate date close to the Christmas holiday period). The score obtained in this test will account for 40% of the final grade. It will consist of several multiple choice questions, a development question and a practical case.

2nd.- Carrying out practical exercises on theory and presenting a series of practical cases in class. These exercises and practical cases will be prepared individually and discussed in the practical classes, obtaining a score from 1 to 10. The average score obtained in the exercises and practical cases will account for 40% of the final grade.

3°.- The preparation and presentation of a group work on one of the program topics. The score obtained in the work will account for 20% of the final grade.

To pass the continuous evaluation, a minimum score of 30% must be obtained in each section and the weighted average of the three sections must exceed 5.

In the Global evaluation modality, the student will take a final written test that represents 100% of their evaluation. This test will consist of two parts:

A first part that will incorporate 5 questions each valued at 1 point/10 on theoretical issues of the program chapters, and whose weight will be 50%.

A second part that will incorporate 2 problems each valued at 2.5 points/10 on theoretical-practical issues of the program chapters, and whose weight will be 50%.
