#### 1. General information

This subject aims to provide the student with the conceptual and analytical apparatus that will enable them to understand the economic policies that states and economic institutions can apply to achieve short term macroeconomic objectives.

In principle, the teaching methodology and its evaluation is planned to be based on face-to-face classes . However, if circumstances so require, they may be carried out online.

# 5. Assessment system

The subject will be evaluated by means of a global evaluation in its two calls, being possible to choose one of the following two modalities:

#### **Evaluation with class participation:**

A 15% of the grade will correspond to the resolution of the cases presented in the classes of the subject. The submission of work outside of class time will not be accepted.

A 25% of the grade will correspond to a midterm multiple-choice test. The exam will include questions related to both theory and practice.

A 60% of the grade will be obtained in the final exam of open-ended questions.

In order to choose this option it will be necessary to obtain, at least, a 4 out of 10 in the final exam.

#### **Final Exam**

A final exam of the entire content of the subject. The exam will consist of open questions related to the content of the theoretical and practical classes; it will assess the approach, development, results and interpretation of the solutions to the proposed problems.

The grade for this exam in this option will be 100% of the grade.

Knowing the result of the two evaluation possibilities described above (1 with class participation and 2 with final exam), the most advantageous option for the student will be applied. In both options, in order to pass the subject, the final grade must be equal or higher than 5.
