1. General information

The Degree Final Project (DFP) is compulsory for all students of the degree in Economics. Its objective is to deepen in topics related to the different areas of the degree integrating the knowledge, specific competencies, transversal competencies and skills acquired throughout the curriculum and applying them to the treatment of the model and topic of the Degree Final Project.

The modalities that the DFP may take are those that appear in the regulations of each of the centres in which the degree is taught.

In any case, the DFP will be materialized in a report or project in written form that will be accompanied, if necessary, by the appropriate material and will be defended in the terms established in the corresponding regulations.

These approaches and goals are aligned with the Sustainable Development Goals (SDGs) of the 2030 agenda and certain specific goals (https://www.un.org/sustainabledevelopment/es/), contributing to some extent to their achievement: Goals 1-17 (the completion of the DFP may include disciplines and subjects related to all SDGs).

2. Learning results

- Be able to demonstrate the integration of the disciplinary competences linked to the Degree in Economics and that have been developed up to the moment of the DFP
- Be able to appropriately handle the terminology and a sufficient knowledge of the issues raised in the disciplines linked to the study of Economics
- Be able to deepen and specialize in an area of interest.
- Be able to make effective use of the specialized bibliography.
- Become familiar with research procedures: documentary research, data collection, analysis and interpretation, and writing a final paper.
- Be able to orally defend the arguments of the work done.
- Be able to perform, under their responsibility, a work that allows them to prove that their work capacity is at the level required of a professional capable of integrating into the labour market.

5. Assessment system

The assessment of the Degree Final Project consists of two parts: the written report of the project, which accounts for 80% of the grade; and the presentation and defence of the project, which accounts for the remaining 20% of the grade.

Working memory

The DFP will be materialized in a report or project in written form in Spanish that will be accompanied, if necessary, by material deemed appropriate. It would be advisable for the student to submit the DFP report to the director(s), at least 15 school days prior to the start of the deposit deadline (the deadlines for deposit and defence are published on the Centre's website).

Défense of the work

The defence of the Degree Final Project will be carried out in accordance with the corresponding regulations published on the website of the corresponding Faculty.

For possible claims to the grade, the procedure established in the current regulations of the University of Zaragoza will be followed.

Assessment criteria:

The assessment criteria for passing the DFP are as follows:

1. CONTENT OF THE PAPER (Maximum 8 points).

The following elements will be assessed:

- 1.1. Approach, justification and objectives of the work. (Maximum 2 points)
- 1.2. Scientific-technical content. (Maximum 4 points)
- 1.3. Discussion of results and conclusions. (Maximum 2 points)

2. PRESENTATION AND DEFENSE OF THE WORK (Maximum 2 points).

The following elements will be assessed:

- 2.1- Presentation (maximum 1 point)
- 2.2- Discussion of the paper and answers to the questions posed (maximum 1 point)

In those cases in which the student carries out irregular practices in the completion of the DFP or in the assessment tests (e.g. plagiarism), the provisions of article 30 of the University of Zaragoza's Learning Assessment Regulations (Agreement of 22 December 2010 of the Governing Council) will be taken into account. To verify this, the appropriate procedures to ensure that the student's own contribution exceeds 80% of the final content of the DFP deposited will be followed.

In order to facilitate and objectify the evaluation of the DFP an assessment rubric may be used, which will be published in the web pages of the centres that agree to use it.
