#### 1. General information

Subject belonging to module three, History and its periodization. It allows the diachronic analysis of the phenomena and historical processes that have taken place in the final stages of Prehistory. In particular, it aims to explain the development and the transformation of full and advanced metallurgical societies, located on the edge of the emergence of the first states. The different cultural groups are explored through documentation obtained from the archaeological record, with special attention to settlement systems, funerary practices, economic activities and technological developments to ultimately reconstruct the social structure of the communities studied.

- 4.- Bronze Age in the Iberian Peninsula. The Argar culture and related groups.
- 5.- Late Bronze and Early Iron Age in Europe. Chronology, economy and society. Urn Fields and Hallstatt culture.
- 6.- Late Bronze and Early Iron Age in the Iberian Peninsula. The urn fields of the Northeast of the Iberian Peninsula, Atlantic Bronze Age, groups of the Iron Age and colonial influences.

### 4. Academic activities

- 4.1- The teaching-learning methodology has been designed to:
- Understand and analyse the contents of the program.
- Follow-up, discuss and test the contents of the practical classes.
- Present problems and current issues related to the subject.
- 4.2- The program includes the following activities:
- Theoretical classes that include informal discussions or debates on topics related to the program.
- Practical classes. Theoretical contents are worked on through various exercises, projection of audio-visuals and study of archaeological materials available in the Laboratory of Prehistory and Archaeology. Tutorials.

# 5. Assessment system

#### 5.1- First call.

Global assessment.

Theoretical exam (60%) and practical exam (40%) to be held on the date and place established by the center. It will consist of three parts:

- a) Short questions (30% of the grade) Definition and/or summary explanation of concepts, authors, sites, cultures, etc., included in the syllabus. The precision of the answers will be valued, as well as the ability to synthesise.
- b) Topic (30 % of the grade) Resolution of a transversal topic that involves the relation of different contents presented in class or included in the program. The correctness of the contents will be evaluated, as well as the formal aspects such as structure, order, precision and clarity, adequate terminology, writing, personal contributions, etc.
- c) Practical test (40 % of the mark) Identify, relate and explain the meaning of a series of images corresponding to settlements, constructions, necropolis, artifacts, maps, pictures or any other element included in the dossier of the subject
- 5.2- Second call. Overall assessment identical in its tests and criteria to those of the first call.
