2. Learning results

4. Academic activities

The program offered to the student to help them achieve the expected results includes the following activities:

- 1) Theoretical classes: lectures by the teaching staff on the theoretical contents.
- 2) **Practical classes:** seminar on a monographic topic with texts proposed by the teacher, with practices of description and interpretation of these texts and argued debate on the same with the rest of the students. visits to art and research centres and other activities of artistic and cultural interest.
- 3) Study and personal work.
- 4) Tutorials.
- 5) Assessment tests.

5. Assessment system

First call

A) Continuous assessment

- Exam (60 %): Development of some questions about the syllabus. Knowledge and understanding of the fundamental contents of the syllabus will be assessed.
- Practice report (20%): Seminars conducted in class on issues or problems related to the subject.

The class will be divided into groups and each group will present the proposed texts. Afterwards, a common discussion of the questions raised by these texts will be held. The argumentative structure in the analysis of the texts and the capacity for reflective argumentation of the different positions on the problems posed will be valued.

- Individual work (20%): written work.

B) Overall assessment

- Exam (60%): Development of some questions about the syllabus. Knowledge and understanding of the fundamental contents of the syllabus will be assessed.
- **Practice report (20%):** Written exercise of analysis and interpretation of artistic materials addressed in the subject. The knowledge, the reflective observation of the proposed works and the argued structure in the analysis will be valued.
- Individual work (20%): written work.

Second call

Global assessment (100%) identical to the first call.
