1. General information

The Master's Final Project (MFP) is an annual compulsory subject that will be defended once the rest of the credits of the Master have been passed. The student will have a maximum of two calls to choose from among four possible ones: February, July, September and November. It consists of the elaboration, written presentation and public defence before a board of the work carried out by the student, for which they will be supported by a director who will be assigned by the coordination of the specialty

The face-to-face nature of the defence will be in accordance with the MPF/DFP regulations in force at the University of Zaragoza

2. Learning results

1. Produce an academic paper containing original contributions by applying the knowledge, skills, abilities, aptitudes and attitudes acquired throughout the master's studies.
2. Work autonomously and responsibly to achieve the proposed objectives.
3. Critically evaluate their own work.
4. Present their work, both orally and in writing, and defend it with order, clarity, argumentative rigor and linguistic correctness

3. Syllabus

No content is defined in this area.

Students may decide to prepare the MFP in mode A or mode B. Mode A: It will consist of an original and integrative report. Based on at least two of the activities carried out throughout the Master's program (annual programming of a subject, didactic unit, innovation or research project, implementation of activities, Practicum experience, etc.), a critical analysis will be made reflecting the integration of the different knowledge and practices of their training process. Optionally, in modality A, some specialties also admit, with the prior consent of the tutor, other models of work in this modality, as stated in the academic guide of the MFP.

Modality B: It will consist of a work of initiation to research related to lines of innovation or research previously communicated by the teachers and approved by the Quality Commission.

The coordinators will be in charge of the assignment of MFP tutors.
