1. General information

The ultimate aim of this subject is to identify and contribute to overcoming the contradictions that arise from the interaction between an inertially homogenizing school culture and an increasingly heterogeneous student body which is especially significant in the different forms of middle school or secondary education.

5. Assessment system

The final grade of the subject depends on two evaluation tests:

- Reading review (50% of the final grade). Elaboration of an individual critical commentary based on academic articles or readings recommended by the faculty within the framework of the subject.
- Directed work (50% of the final grade). Preparation of a group work on one of the central topics of the subject to be agreed upon with the faculty. It includes the presentation and oral defence of such work.

In order to pass the subject it is necessary to pass each of the evaluation tests.

Overall test and second call.

The global evaluation, following the current regulations, will consist of an overall test based on a written test, the design and justification of a didactic and organizational proposal for students with different specific needs of educational support, justifying the reasons for it; as well as a brief essay on one of the contents of the subject

In the second call, each student may choose between an overall test following the model of global evaluation described above, or to do again the evaluation test that they did not pass initially (this partial grade is kept only within the same academic year).

-Fifth and sixth call. In the same terms as the global evaluation.

Finally, it must be taken into account that the Regulations of the Norms of Coexistence of the University of Zaragoza will be applicable to the irregularities committed in the evaluation tests by means of academic fraud, as well as the application of article 30 of the Regulations of the Norms of Evaluation of Learning in relation to irregular practices other than academic fraud.
