1. General information

External Practices is an optional second-cycle subject that can be taken in the third and fourth years. It is situated in the second half of the degree, after an important period of previous training, during which each student has already had to integrate the fundamental theoretical and methodological knowledge of the artistic disciplines. The aim of this subject is to offer each student a direct experience of the professional world, observation and accompaniment in the different tasks involved in the profession of Fine Arts, giving each student the opportunity to apply artistic methodologies in the field of work that interests them.

The subject is aligned with SDG 4 Quality education, 5 Gender equality, 10 Reducing inequalities and 12 Responsible production and consumption.

2. Learning results

Each student must achieve the following results in order to pass this subject:

1. Understand and be able to develop activities related to the Fine Arts degree.
2. Know the legal framework that regulates professional practice.
3. Recognise and critically assess the contributions provided by scientific research and theoretical knowledge to the professional practice observed.
4. Recognise and critically assess the methodological foundations acquired in the Degree in the professional practice observed.

3. Syllabus

External Internship is a subject with a flexible schedule that allows students to define their stay during the current academic year, specifying the start and end of the internship at the convenience of the student and the host company or institution. Each student must complete a total of 150 hours, which is estimated on the following schedule to be carried out:

5. Assessment system

At the end of the placement period, each student must ensure that the following documents are sent to his/her academic tutor:

1st) Assessment of the professional tutor, through the Assessment Report of the professional tutor.

2nd) Each student must complete their Final Work Placement Report using the template provided for this purpose, which includes the self-assessment form.

With these documents, the student's academic tutor must carry out;

3º) Overall assessment through the academic tutor's Assessment Report, taking into account the documents in steps (1) and (2), according to the template provided in which the competences to be achieved are assessed with the structure; development of the placement (20%), placement report (50%) and assessment of the professional tutor (30%).

4) With the assessment carried out, the academic tutor will communicate the final grade to the centre's secretary's office (secreter@unizar.es) so that the corresponding individual assessment report can be generated.
