G.W.F.Hegel in the Preface to his Principles of the Philosophy of Law, writes that "philosophy is its time apprehended in thoughts". In line with the different currents and theoretical proposals, the main philosophies of Political Philosophy will be critically presented.

FIRST CALL

A) Continuous assessment system
