The subject "History of Contemporary Spain: 19th century" has as its essential objective to provide students with a reflective, systematic and critical understanding of the social, economic, political and cultural processes of 19th century Spain in interrelation with the European context and leading to a later deepening in the 20th century.

### 2. Learning results

Demonstrate a basic knowledge and a general and overall vision and interpretation of the main historical phenomena that are emphasized throughout the term.

Analyse and interpret historical texts, graphs and statistics.

Demonstrate sufficient knowledge of a basic bibliography related to the topics of the subject suggested by the teachers.

Demonstrate knowledge and skills to find information and materials that allow them to deepen in specific aspects of the subject and suggested in it.

Organize complex historical information in a coherent manner in order to interpret it in a reasoned way.

#### 4. Academic activities

1) Theoretical classes: 37.5 hours

Classroom explanation of theoretical contents. Master class.

2) Practical face-to-face classes: 15 hours

Seminars in which questions or problems related to the subject of study are raised, discussed, debated and solved.

Comments and analysis of sources and texts.

3) Personal work of the student: 82.5 hours

Assimilation of contents; elaboration of an individual work; individual search for information in bibliographic and documentary sources.

4) Tutorials: 10.5 hours

Guidance of student learning and discussion of problems encountered.

5) Assessment tests. 4.5 hours

## 5. Assessment system

#### First call.

- a) Continuous evaluation (enrolment not exceeding 25 students).
- Written examination of the entire subject. 50% of the grade. Assessment criteria: the acquisition of knowledge, structuring, reflection and exposition of the topics to be developed will be evaluated.
- Individual work related to a specific part of the program. 30% of the grade. Assessment criteria: the following will be assessed: , ability to search for information, comprehensiveness and analysis of the information consulted, and writing and exposition according to academic rules.
- Participation in practical classes. 20% of the grade. Assessment criteria: the willingness to participate actively, as well as the clarity of the presentation and the level of reflection and interpretation in the interventions will be evaluated.

b)Global assessment test

- -Written exam that will include the development of concepts, topics and a text commentary. 80% of the grade. Assessment criteria: acquisition of knowledge, structuring, reflection and exposition of the topics to be developed, and mastery of text commentary.
- -Review: 20% of the grade. Assessment: synthesis, most relevant aspects of the work and critical opinion

Second call.

Global test: 100% of the grade Assessment criteria: the same as those of the global test in the first call.
