1. General information

The subject "Historiography" has as its fundamental objective to provide students with a critical understanding of the disciplinary development of historical science and the processes of formation of national communities of professional historians . In a transnational perspective, the specific objectives focus on the knowledge of the main international historiographies, historical theories and historiographic practices.

2. Learning results

In order to pass this subject, students must demonstrate the following learning results:

Critically read and demonstrate an understanding of historiographical texts.

Identify and directly use different historical sources and critically evaluate them.

Use historiographic information resources (bibliographic, archival, computer and technical).

Express and argue orally and in writing in Spanish, using the concepts, vocabulary, terminology and techniques of the professional historian.

To develop sensitivity to the study of the past, to the sources for its knowledge and the disciplinary formation of the history of historiography.

To gather, organize, interpret and disseminate relevant data in order to learn about and critically reflect on the historical discipline and the value of the epistemic virtues inherent in the profession of historians.

4. Academic activities

Theoretical classes: 37.5 hours
Classroom explanation of theoretical contents. Master class.
Practical face-to-face classes: 15 hours
Seminars in which questions or problems related to the subject of study are raised, discussed, debated and solved.
Comments and analysis of sources and texts.
Personal work of the student: 82.5 hours
Assimilation of contents; elaboration of an individual work; individual search for information in bibliographic and documentary sources.
Tutorials: 10.5 hours
Guidance of student learning and discussion of problems found.
Assessment tests. 4.5 hours
TOTAL: 150 hours.

5. Assessment system

a) Continuous assessment system (in case of an enrolment of no more than 25 students).

First Call: Class attendance and participation in classroom activities (20%). Critical debate in the classroom: evaluation of students' interventions on the issues raised in the classroom (20%). Individual written work : evaluation of an essay on a specific topic or problem of the subject program (60%).

Assessment criteria: oral presentation skills, the search for information and the extent of the information consulted will be evaluated ; also, the analysis of the information, as well as the writing of the paper, according to the academic rules.

Second call Identical to the first.

b) Global assessment system.

First Call: The global evaluation test will consist of a written exam on the totality of the subject (contents and texts worked on in the subject). The content of the test will consist of the development of two topics and an historiographic text commentary. 100 % of the grade. Assessment criteria: acquisition of knowledge, and structuring, reflection and presentation of the topics to be developed, and mastery of text commentary.

Second call: global assessment. Identical to the first one.
