### 1. General information

The goal of this subject is to show and learn the techniques and tools used in contemporary public management, and the processes of both internal and external control of the public sector in order to achieve greater efficiency in spending and in the management of available resources.

These approaches and goals are aligned with the Sustainable Development Goals (SDGs) of the United Nations Agenda 2030 United Nations, in such a way that the acquisition of the learning results of the subject will contribute to the achievement of the following objective 4.4 and 4.7 of Goal 4 and objectives 17.13, 17.14, 17.15 and 17.7 of Goal 17.

### 4. Academic activities

#### 4.1. FACE-TO-FACE ACADEMIC ACTIVITIES

#### 4.2. VIRTUAL ACADEMIC ACTIVITIES

## 5. Assessment system

### 5.1. PRESENCE-BASED MODALITY

In the first call there are two evaluation systems for both face-to-face and virtual students:

**5.1.1. Continuous evaluation:** Individual completion and discussion in class of a series of theoretical and practical questions.

The evaluation criteria will take into account the ability to apply the contents of the subject to the subject matter, the rigor of the documentation, the capacity for autonomous reasoning and the absence of formal errors.

The final grade will be obtained by the average grade of all the papers presented. In order to mediate, all the proposed practices must be submitted to and a minimum of 4 out of 10 points must be obtained in each one of them.

**5.1.2. Global test:** individual written test of short questions. The final grade will represent 100% of the grade (up to a maximum of 10 points).

In the second call, the evaluation will be carried out by means of a global test that will have the same structure as in the first call first call.

### 5.2. VIRTUAL MODE

The only difference between the face-to-face and virtual modality is that the continuous evaluation will be done online through the digital teaching ring (ADD) with videoconferencing tools, assignments and quizzes in Moodle.
