#### 1. General information

The academic approach of the subect of Criminal Law, Special Part, has as its main goal that the student to know, interpret and correctly apply all the criminal offenses of our criminal legal system.

#### 4. Academic activities

### 5. Assessment system

There are two systems:

- 1) Mixed system consisting of the following activities:
- a) Assessment of active participation through the completion of tests, assignments or case studies throughout the term.

The overall result of these will be weighted by 30% of the final grade.

In any case, students who have not achieved an average of 5 (pass) in this part of the grade, will have to the other assessment method, based exclusively on the final global test.

- b) Final global test. It will consist of a series of theoretical-practical questions to be answered based on the learning results that have been developed during the term. The grade will be weighted 70% in the final grade. Students who do not obtain in this final written test a minimum grade of 5 out of 10 points will not pass the subject. Only on the basis of this score will the assessment grade of the activities developed during the coursebe weighted.
- 2) Simple system based exclusively on the final global test consisting of two parts:
- a) The completion of the test of the previous section (final global test).
- b) Completion of a written exercise on the content of the subject, which demonstrates that they know how to analyze an issue from the perspective of criminal law

The final grade of the overall test will be obtained from the weighted average of the exam grades, 70% for the first part and 30% for the second part, although in order to pass it is necessary to achieve at least a 5 out of 10 in each of them.
