#### 1. General information

The master's final project (MFP) will consist of a report or project in which the student will present the knowledge, skills, aptitudes and attitudes acquired throughout the degree.

The result is therefore the implementation of the knowledge acquired by the student.

The MFP will follow one of the lines of work resulting from the topics taught within the framework of the Master's Degree in Auditing.

Students should consult and be familiar with the regulations and instructions on Degree's and Master's Degree Final Projects of the University of Zaragoza and the specific regulations of the Faculty of Economics and Business, available on their respective websites.

These approaches and objectives are aligned with the following Sustainable Development Goals (SDGs) of the United Nations Agenda 2030 (<https://www.un.org/sustainabledevelopment/es/>), so that the acquisition of the learning results of the subject provides training and competence to contribute to some extent to the achievement of targets 4.4 of Goal 4, 8.6 of Goal 8 and 16.6 of Goal 16.

#### 2. Learning results

The MFP is the subject that concludes the study plan and involves the completion of a project, report or original study, under the supervision of one or more directors. In this work, the student must individually integrate and develop the training content as well as the skills and abilities acquired during the teaching period of the master.

The MFP is associated with the assessment of the general competences of the master that confirm the necessary skills for the practice of the profession.

This subject enables the student to search, manage, organize and interpret relevant data, to make judgments that include a reflection on relevant social, scientific, technological or ethical issues, as well as to develop critical, logical and creative thinking and judgment.

The production of the work allows to integrate the student's training and also to consolidate their autonomy to face new problems and situations as they will have to do in their immediate professional future.

#### 3. Syllabus

The lines or list of topics on which to focus the MFP, as well as the possible directors for each of them, are published on the Faculty's website.

The guidelines on the methodology, format, extension and structure for its preparation will be provided to students at the beginning of each academic year, through the ADD (*Anillo Digital Docente*) of this subject, and information sessions will be held in the classroom.

#### 4. Academic activities

In this subject there are no face-to-face classes, so the academic activities are 100% non-face-to-face.

Once the student has selected the work type, they should contact the director(s) of the chosen option

The director(s) will decide whether or not to accept the student's request to direct their MFP. In the event that they accept the direction of a student, they will be responsible for validating and supervising the MFP process. The meetings with the director/s will be mutually agreed.

As mentioned above, the MFP consists of the preparation and defence of a report.

The TFM report is an individual written work that must contain sufficient elements of personal creation, and all sources used must be properly cited. The author(s) may include the annexes and materials they deem appropriate.

In any case, the MFP must contain at least: title, name of the master's degree to which it is linked, modality of work, director/s, objectives and abstract (200 words).

## 5. Assessment system

The work prepared must be deposited and defended in accordance with the rules of the University of Zaragoza and within the deadlines established by the Faculty of Economics, published on its website.

### Deposit of the MFP.

Students must deposit their MFP at the Secretary's Office of the center, with the approval of the director or co-directors. There are three possible deadlines, as can be seen on the faculty's website: <https://econz.unizar.es/informacion-academica/trabajo-fin-de-master>

Format of the deposit: works should be submitted in text files and static images according to the official formats and guidelines of the University of Zaragoza, unless the content of the subject requires a dynamic format.

### Defence of the MFP.

The defense may be performed once it has been verified that the student has passed the rest of the subjects leading to the official degree. The deadlines can be found on the web page of the Faculty of Economics and Business. The master's final project board of examiners will publish a list with the date assigned to each student for the defence and the place where it will take place.

**Assessment of the work** The criteria for the assessment of the work are the following:

1. CONTENT (Maximum 8 points).
2. PRESENTATION AND DEFENCE (Maximum 2 points).
