## 1. General information

The subject challenges students to put into action the competencies and skills learned during the study of the degree, while developing more specific ones by analysing problems and seeking solutions by applying research techniques from different areas of knowledge.

It consists of carrying out a research project with a gender perspective, whose development will be supervised by a specialist in the subject who must be a doctor or share the direction with a doctor.

## 2. Learning results

- 1.- Know how to elaborate an innovative individual project including the transfer of women's thinking as a subject of knowledge.
- 2.- Apply quantitative and qualitative social research techniques depending on the texts and discourses of the different areas of the specialty.

### 3. Syllabus

Given the specificity of this subject, the program includes all the subjects taught in the specialty. The research topic must be agreed upon with the director in order to develop a project that will result in the MFP

#### 4. Academic activities

The direction of the MFP will be carried out through tutorials, corrections and revisions of the document that will constitute the research. For this purpose, tutorials will be arranged with the Director as often as deemed necessary.

The way to develop individualized learning will be agreed upon with the Director.

## 5. Assessment system

Students will develop the concepts of the subject and the criterion of mastery of the theoretical and operative knowledge acquired. The evaluation of the MFP will be done by means of the oral examination technique with the defence of the MFP and p before a board of examiners. The MFP, which will consist of a written report, which as a general rule, must conform to the characteristics of all scientific work and contain at least:

Introduction: where the subject matter, general and specific objectives, hypotheses (if applicable), and theoretical relevance are

clearly expressed.

Objectives and methodology.

Theoretical framework: where the specific bibliography on the subject, its background, the main contributions on the subject, as well as other related aspects that the student and their director will

deem appropriate. The necessary chapters will be included to develop the critical analysis of the chosen topic.
