1. General information

The main objective of the Master's Thesis consists of the integration of the skills acquired throughout the master's degree. To this end, the Master's Thesis proposals will be prepared according to a work plan related to the Circular Economy, which highlights the knowledge, skills and aptitudes acquired by the student. In this work, the student must demonstrate that he is able to adequately manage time, search for and manage bibliographic information related to the topic of work and carry out the measures, operations or protocols necessary for the acquisition of information. The work is captured in a report, which must be defended before an academic committee.

2. Learning results

- To be able to develop individual and original work
- To be able to write and publicly defend a research work

3. Syllabus

Each student chooses a topic for their Master's Thesis among those offered by the departments involved in teaching the Master's Degree.

4. Academic activities

All work is tutored by the Master's Thesis directors, who can organise periodic appointments.

To prepare the draft of the memory, the student must carry out autonomous work (use of the library, review of the literature, writing the draft of the dissertation and revising the draft).

5. Assessment system

The procedure to follow is included on the website of the Master's Degree in Circular Economy (<https://ciencias.unizar.es/master-en-economia-circular>).

Once the report of the Master's Final Project has been deposited, the student defends it before an academic committee. This committee qualifies the work applying the following criteria.

1. Master's Final Project Report The rigor of the different chapters of the report, the work methodology and the quality of the results are judged (always considering the student's level of competence), as well as the adequate written presentation taking into account that it is an autonomous work carried out by the student. under supervision. This section is valued at 50 % of the final grade.

2. Presentation of the Master's Final Project The ability to concisely and accurately transmit the objectives, results and conclusions of the Master's Thesis is judged. Likewise, how the student defends his work will be judged according to the knowledge and skills previously acquired in his training. This section is valued at 40 % of the final grade.

3. Report of the Director of the Master's Final Project The instructions of the Director of the Master's Final Project regarding the work developed by the student are valued. This section is valued at 10 % of the final grade.

In the event that the Master's Final Project is classified as Failed, the academic committee must issue a report detailing the deficiencies of the Master's Final Project, both methodological and content, that have led to such consideration, indicating the modifications that will need to be carried out for its defense in another call. Detection of plagiarism in the report may result in a Fail grade.

In the grading of the Master's Thesis, for the mention "Honours" the limitation of 5 % of enrolled students does not apply.
